- Dr. Tuso asks about to timeframe to build the new hospital. Mr. Mirzabegian responds with the 36-month build schedule. Further discussion regarding the requests for additional patient rooms, interventional rooms, hospitalist offices, and CT. This may result in an additional floor.
- Mr. Rives comments on the ED Expansion and the Kindred Joint Venture. Mr. Rives noted that these projects have not been completed. Mr. Mirzabegian noted that all projects are on parallel tracks and are on schedule. Mr. Rives inquired as to whether the hospital has attempted to obtain HUD and VA Funding.
- Ms. Hong asks Mr. Rives if he has acted on his campaign platforms regarding HUD Funding for the build of the new hospital.
- Mr. Rives answers that he has not acted on or requested funding from HUD or VA resources. Mr. Rives further stated that he has no authority, as an elected official, to ask for such funding.

MOTION: Dr. Tuso made a motion to approve the FLM Letter of Intent; Ms. Hong seconded. The motion passed 3:1 with Rives abstaining. Dr. Parazo was absent from the meeting.
