1. Approval of January 2021 Financial Report (ACTION) – Ken Robinson, CFO

Mr. Robinson presented the financial report for January:

Second month in a row with strong inpatient revenue and low outpatient revenue.

Revenue was \$33M.

Samaritan's Purse helped the hospital with labor costs.

January was the final month of COVID paid time off.

Decrease in contract labor this month

Drug costs have been very high - \$2.5M

Continue with a strong cash position.

Mr. Rives asked why the ER visits are down. Mirzabegian stated that COVID has made an impact on the ED volumes.

How much did it cost for Samaritan's Purse and FEMA? Mr. Mirzabegian stated FEMA was free and the City helped the hospital with Samaritan's Purse costs.

Mr. Rives asked about the hospital contracting for themselves for nursing? Mr. Mirzabegian stated that this is in the works and that the hospital should have a draft contract sometime in April.

Mr. Rives asked about the Medicare advance money and the timeline to pay it back. Mr. Robinson stated that the hospital has two years to pay this back.

A. COVID-19 Summary & Update

Mr. Mirzabegian presented the COVID statistics for February. From last March the hospital has seen 6959 patients for COVID, of which 3339 were positive. 1513 admitted 19 patients currently in-house.

366 deaths - 10.9%

Vaccination for our employees are ongoing. We have given 4000 doses so far. The hospital will be vaccinating the teachers in the community starting next week.

The hospital is in the process of NCA

The hospital started three new programs: Watchmen, Bariatric Surgery and TAVR

Samaritan's Purse recently left the hospital campus – they helped with 169 patients and were a great help to the hospital. The hospital is very thankful to Samaritan's Purse.
