- Net Patient Revenue Trends June 2019 June 2021
 - Over by 10% in net patient revenue.
 - Higher case mix index. Higher ER Visits.
- EBIDA Trends June 2019 June 2021
 - End of Month/Year shows a good EBIDA
- Statement of Income June 2021
 - EBIDA 300% over budget/7.5M over
 - Total Operating Revenue: 25.5% over budget
 - Net Patient Revenue over by 10%
 - Positive trends in Case Mix Index
 - Increase in ER Visits

Dr. Farrukh asks about the Total Operating Revenues at \$47M, is that the total for the month?

Mr. Vitello and Mr. Mirzabegian answer the question and discuss the total operating revenues.

- Statement of Income YTD
 - Pension Liability and Workmans Comp adjustments that are being reviewed

Dr. Farrukh asks with the Pension Liability, do we a handle on exactly how much this will be?

Mr. Mirzabegian, Dr. Farrukh, and Mr. Vitello discuss the pension liability, actuary, and the pension plan.

Dr. Tuso asks about interest rates and where we are on those numbers? Mr. Vitello and Mr. Mirzabegian review and discuss the interest rates.

 - Noting the increase in Trauma cases, ER Visits and Increasing ER Beds by the end of the year.
